DROP-OFF & PICK-UP POLICY: All Campers – Drop off & sign-in on the curb of "The By Ear Musician Studio of Music Instruction": 8:45 – 9:00am. Pick-up: 5:00 – 5:15pm. After this time, please walk camper inside for drop off & come in for pick up. No unsupervised children are allowed on the "The By Ear Musician Studio of Music Instruction" property. Any child not picked up by 5:30pm will be brought to the auditorium. An instructor will remain with them until an authorized person comes to take them home. **There will be a fee for this service at the rate of \$30/hour, charged in half-hour increments. This fee must be paid before the child is allowed to return to summer camp. If any child is absent from the program for two days due to unpaid late pick-up fees, that child may be dismissed from the summer camp with no refund.

CAMP CONDUCT & DISMISSAL POLICY

We welcome all young actors to our camp. DanceCentral! Entertainment, LLC., is a professional theater, and in order to maintain a professional atmosphere, we ask that young actors:

- Behave in a manner that respects themselves, other campers. DanceCentral! Entertainment, LLC. The By Ear Musician Studio of Music Instruction and/or DanceCentral! Entertainment, LLC. & property.
- Wear appropriate clothing. Students will be performing/dancing throughout the day and backless shoes can be dangerous. We suggest shoes with a closed toe and heel, tennis shoes or sneakers are best. Workshops require physical movement, and many exercises require sitting or lying on the floor. Students should wear clothes that they can move in comfortably. Please do not send your children to camp wearing clothing with profanity, references to drugs or other inappropriate messages.
- Students should bring a smock or cover up (an old oversized shirt, for example) that will protect clothing from paint, glue, make-up, etc. used in technical theatre and craft classes.
- Attend all rehearsals. Learn the lines. Students may be reassigned to a non-performance activity if the Camp Director determines that these requirements are not being met.
- Do not go anywhere in the building without a teacher's knowledge and permission.
- Stay on the premises until your instructor releases you to an authorized person.
- Bring lunch and two snacks (including drinks) daily. Microwaves, refrigerators and vending machines will not be available.
- Do not bring glass containers, chewing gum, headsets or video games to camp.
- DanceCentral! Entertainment, LLC., reserves the right to dismiss any student from the program for behavior that jeopardizes the safety of the participants and staff and/or disrupts the learning, rehearsal or production process. Bringing alcohol, drugs or weapons to the program will be cause for automatic dismissal. No tuition refund will be issued for any child dismissed for behavioral reason.
